British American Racing - Registration of a Form 400

Further to our conversation of yesterday please find enclosed copies of the recent correspondence we received from Companies House as well as the Form 400 and supporting material which we submitted.

From reviewing the correspondence between Norton Rose and Companies House, I understand that the Form 400 was refused registration for being a day out of time and that it was received in your Edinburgh office. To summarise our conversation we sent the Form 400 at the same time as we sent a Form 395, related to the same transaction, which was successfully registered, to your London office.

I can confirm that my colleague who is responsible for the registrations at Companies House has reviewed his list of receipts from couriers which he always uses to send material to Companies House for the days surrounding the date on which Form 395 and Form 400 were sent to your London office. He has confirmed that there were not any courier packages sent to your Edinburgh offices.

I am assuming that the Form 400 was received in your London office at the same time as the Form 395 and somehow was transferred to your Edinburgh office resulting in the Form 400 being received one day out of time.

I would appreciate if you could review the records to confirm that this is the case since as I mentioned on the telephone should you be unable to register the Form 400 I will be required to explain to my client why, despite the fact that both Forms were sent on the same day, the Form 395 was registered and the Form 400 was not.

I very much appreciate your personal attention to this matter.


