ORDER

UPON the application of David Thornhill ("Applicant") for a Block Transfer Order dated [2020

AND UPON READING the witness statement of the Applicant dated [#5] 2020 in support of the Application and the Respondents consenting to the Application

IT IS ORDERED that:

- 1.
