NOTES TO THE ACCOUNTS Year ended 30 September 1999

1. ACCOUNTING POLICIES

The particular accounting policies adopted are described below.

Accounting convention

The financial statements are prepared under the historical cost convention.

2. PROFIT AND LOSS ACCOUNT

Throughout the year the company acted as an agent for Barrett Steel Limited with all income and expenditure being transferred to that company.

The turnover for the year ended 30 September 1999 transferred to Barrett Steel Limited was £4,997,000 (1998: £6,338,000).

It is not possible to separately determine the other income and expenditure of the company as they are combined with other agency subsidiaries of Barrett Steel Limited for accounting purposes.

The company has made neither profit nor loss nor any other recognised gains or losses in the current and preceding financial year.

4. CONTINGENT LIABILITIES

The company is party to a multilateral-guarantee dated 4 March 1994 which secures all the borrowings of the group with HSBC Bank plc. At 30 September 1999, the maximum contingent liability arising under this guarantee was £6,070,000 (1998: £6,377,000)

The company is a wholly owned subsidiary of Barrett Steel Limited, incorporated in Great Britain and registered in England and Wales, which is also the ultimate parent company.
