

THE SCHEDULE ABOVE REFERRED TO

"The capital of Britannic Assurance Public Limited Company was by virtue of a Special Resolution of the Company and with the sanction of an Order of the High Court of Justice dated 19 May 1999 reduced from £12,063,500 divided into 239,999,999 ordinary shares of 5p each, 1 unit of ordinary stock of 5p and 63,500 units of preference stock of £1 each to £12,000,000 divided into 239,999,999 ordinary shares of 5p each and 1 unit of ordinary stock of 5p.
