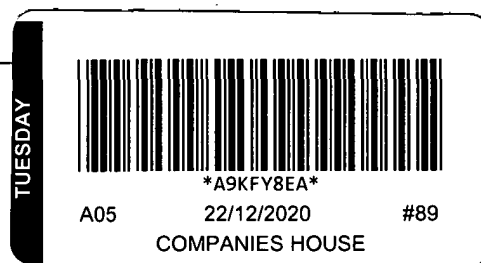

## 1. SUMMARY OF EVENTS

<b>Progress of the liquidations during the report period</b>	<ul style="list-style-type: none"> <li>• The matters completed during the report period include mandatory liquidation tasks such as statutory advertising, filings at Companies House, notifications of the liquidations and completion of pension searches. In addition, a six monthly case review has also been carried out.</li> <li>• The Liquidators also liaised with the Companies and their tax advisors with regard to the submission of outstanding tax returns and the resolution of outstanding tax matters.</li> <li>• PAYE/NIC clearances have not yet been obtained.</li> <li>• VAT clearances have not yet been obtained.</li> <li>• Corporation tax clearances have not yet been obtained.</li> <li>• There have been no receipts or payments in any of the Companies during the period.</li> <li>• The liquidations remain open whilst the position in relation to former employee claims is addressed. Once dealt with, the Joint Liquidators will progress the liquidations to closure.</li> </ul>
<b>Costs</b>	<ul style="list-style-type: none"> <li>• Our remuneration was fixed by the members of the Companies on a time-cost basis. As there are no funds in the estates, our remuneration and costs are currently being met by an associated company, T S Global Holdings PTE. Limited, and are being billed as part of a wider corporate simplification project.</li> </ul>
<b>Outstanding matters</b>	<ul style="list-style-type: none"> <li>• Outstanding tax clearances will be sought from HMRC.</li> <li>• Statutory closing procedures.</li> </ul>

### **2.2 Liquidators' Remuneration**

As there were no funds in any of the estates, our fees are currently being met by T S Global Holdings PTE. Limited. Our remuneration and costs are being billed as part of a wider corporate simplification project.

Such requests must be made within 21 days of receipt of this report, in accordance with Rule 18.9 of the Rules.

#### **3.2 Members' right to challenge Remuneration and/or Expenses**

Members of the Company with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the Company, or, any member with permission of the Court, may apply to the Court for one or more orders (in accordance with Rule 18.34 of the Rules), reducing the amount or the basis of remuneration which we are entitled to charge or otherwise challenging some or all of the expenses incurred.

Such applications must be made within eight weeks of receipt by the applicant(s) of the progress report detailing the remuneration and/or expenses being complained of, in accordance with Rule 18.34 of the Rules.

Please note that such challenges may not disturb remuneration or expenses approved or deemed to be approved under prior progress reports.
