- 1.3 By the deletion therefrom of the existing clause 1 and by the substitution therefor of a new clause 1 as follows:
 - "The name of the Company is The Portsmouth Harbour Ferry Company Limited".
- By the deletion therefrom of the existing clause 2 and by the substitution therefor of the following new clause 2:
 - "The Company is a private company limited by shares".
 - But that save as aforesaid the Memorandum shall remain in full force and effect and unaltered.
- THAT the draft regulations produced to the meeting and initialled by the chairman for the purposes of identification be and are hereby adopted as the Articles of Association of the Company in substitution for and to the exclusion of all the existing Articles of Association.
