The objects for which the Company is established agree-

- (1) To purchase or lease upon such terms and conditions as may be deemed advisable, land situate at Edghaston or elsewhere, in our mear the County of Warwick, and to form and lay out the same as and for the carrying on of Cricket, Football, Athletic, and other Sports, Exercises, Pastinus, and Recreations.
- (2) To creek on the said land a Grand Stand, Refreshment and other Rooms, and to fence out the said land from the lands and reads adjoining, and to maintain, enlarge, or after the same when so creeked as may be thought expedient, and to do all other acts and things for the purpose of ferming and laying out the said land for the purposes aforesaid.
- (3) To purchase, take upon lease, hire, as otherwise acquire such lands, buildings, or other property (real or personal), or such estates, at interests, or rights, or privileges, in or over any lands, buildings, or property as may be considered necessary or expedient for the purposes of the business of the Company, and to erect any buildings which may be thought necessary or expedient for such purposes, and to a any such things, notwithstanding that in any case the whole of the lands, buildings, or property may not be actually required for such purposes.
