UPON THE APPLICATION by Claim Form dated 7 November 2016 of (1) the above-named The West of England Ship Owners Mutual Insurance Association (London) Limited whose registered office is situated at Tower Bridge Court, 226 Tower Bridge Road, London, SE1 2UP ('**WoE London**') and (2) the above-named The West of England Ship Owners Mutual Insurance Association (Luxembourg) whose registered office is situated at 31 Grand-Rue, L-1661 Luxembourg, G.D. Luxembourg, for among other things the sanction of an insurance business transfer scheme ("**the Scheme**") pursuant to Part VII of the Financial Services and Markets Act 2000

AND UPON an Order of Hildyard J dated 17 February 2017 sanctioning the Scheme and making ancillary orders giving effect to its terms

AND UPON an Application by application notice dated 24 October 2017 of WoE London for its dissolution without winding up pursuant to s.112(8)(b) of the Financial Services and Markets Act

AND UPON READING the Third Witness Statement of Mark Howard Pender dated 24 October 2017

AND UPON HEARING Counsel for the Applicant

IT IS ORDERED that WoE London shall be dissolved without winding up at noon on 20 December 2017.

AND IT IS ORDERED that the Applicant's solicitors shall serve a sealed copy of this Order on the Registrar of Companies at Companies House as soon as practicable upon receipt.
