MEMBERSHIP

Scott, Steven Bonfield, Greg Dolan Roderick, J. Garden, Teresa M. Camidge, Kevin G. Floyd, Caroline L. Mitcheson.

THE SOCIETY'S ADMINISTRATION

Your Committee continued to meet on a regular basis throughout the past year and has dealt with a substantial amount of business. In an effort to improve the service from Halifax County Court District Judge Slim has organised informal meetings to discuss the running of the County Court. These meetings have been attended by Mr. Steele and Mrs. Tighe and have proved useful in affording a 2-way communication.

The Committee has continued to support the seminars run with Huddersfield University and was also helped by the Regional Secretary of the Law Society, Ian Crofts, who held a seminar on practice management. More of these seminars are to follow.

Your President and Secretary attended the Annual Conference of Presidents and Secretaries at Umist, Manchester and reported to the Committee.
