The principal terms on which assistance will be given are:

- 1. Under the Loan Agreement BHL will have the benefit of a loan from the Company, the principal terms of which are:
 - the loan will be in an amount equal to the consideration payable pursuant to the (A) Share Purchase Agreement between the Company and BHL relating to the share capital of TCBL (less the amount outstanding (as at the date of the Share Purchase Agreement) under a loan facility from BHL to the Company);
 - BHL shall repay the amounts of the loan outstanding from time to time plus any (B) accrued interest for the time being outstanding under the loan agreement (the "Outstandings") on demand;
 - (C) BHL may on giving 2 business days' notice repay the Outstandings in such amounts and on such dates as it chooses:
 - (D) the Outstandings will accrue interest for each successive 3 month interest period at the percentage rate per annum which is the aggregate of LIBOR (being the percentage per annum equal to the British Bankers Association Interest Settlement Rate) offered for 3-month deposits in pounds sterling two business days prior to the first day of each successive 3 month interest period, plus 0.9% per annum; and
 - (E) all sums payable by BHL under the loan agreement shall be paid free of any restriction or condition and, except to the extent required by law, without deduction or withholding.
