

**1. Accounting Policies**

**1.1. Accounting Convention**

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

The company has not traded, made profits or losses nor incurred any liabilities during the period ended 31 March 2010. Therefore, no profit and loss account is attached.

The company had ownership of 50% of the ordinary share capital of Chamberlink Limited, a joint venture company with Manchester Solutions Limited. Chamberlink Limited is a company registered in England and Wales.

On August 1<sup>st</sup> 2009, the company entered into a share exchange agreement with Manchester Solutions Limited. This resulted in the Greater Manchester Chambers of Commerce's shareholding in Chamberlink Limited being exchanged for 20 A Ordinary shares in Skills Solutions Limited, representing 20% of the equity of that company. As part of this transaction the trade and assets of Chamberlink were purchased by Skills Solution Limited.

As part of this transaction a value of the investment was agreed between the parties. This value, being £286,000, is currently not recognised as an asset in the balance sheet of this company.
