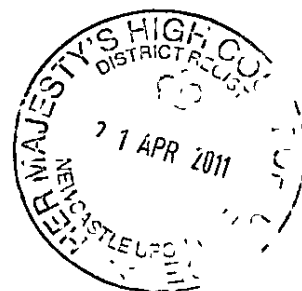

UPON THE APPLICATION by a Claim Form dated 29th March 2011 of Wendy Isabel Clark and Paul Raymond Green (Administrators of the Estate of Raymond Green (Deceased)) creditors of the above named TDE (1980) Limited (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the Evidence of Service of Gill Connelly and exhibit thereto

AND the Claimant by their solicitors undertaking to

- (A) inform the Registrar of Companies of the title and Court reference number of the proposed litigation referred to in the Brief details of claim to the Claim Form issued on 29th March 2011 immediately after issue
- (B) inform the Registrar of Companies immediately on the conclusion of the said proposed litigation or any appeal therefrom or the conclusion of the claim by any other means

- (C) unless the said proposed litigation is completed in the interim, at 6 monthly intervals from the date of the order serve on the Registrar of Companies a full and sufficient Witness Statement setting out what steps have been taken to progress the said litigation

AND UPON the solicitors for the Claimants and the Registrar of Companies (the Defendant) both consent to this Order

IT IS ORDERED that.

- (1) the name of the above TDE (1980) Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 29974 Limited
- (3) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) in the event that the Claimants fail to comply with undertaking (C) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimants

AND THIS COURT FURTHER ORDERS that,

on the Claimants' application, the Claimants the said Wendy Isabel Clark and Paul Raymond Green (Administrators of the Estate of Raymond Green (Deceased)) do recover the costs of and incidental to this application from the said company in the event that their claim for damages against the said company is successful.
