For an individual, his present Christian name(s) and surname must be given, together with any previous Christian name(s) or surname(s).  'Christian name' includes a forename. In the case of a peer or person usually known by a title different from his surname, 'surname' means that title. In the case of a corporation, its corporate name must be given.
