

"Borrower" means Woodside GP Limited (Registered number 03664489) as general partner of the limited partnership carrying on business under the name of Woodside Limited Partnership (registered under the Limited Partnership Act 1907 with registered number LP6285).

"General Account" means the account referred to in clause 11.1(a) (Designation of accounts) of the Credit Agreement.

"Permitted Payment" means, any payment of any distribution by the Borrower out of monies released from the General Account in accordance with clause 11.5 (Withdrawals from the General Account) of the Credit Agreement.

"Senior Liabilities" means all Liabilities arising under or in connection with the Credit Agreement to the Bank or any of them.

"Subordinated Creditors" means Brixton Estate plc and The Equitable Life Assurance Society.
