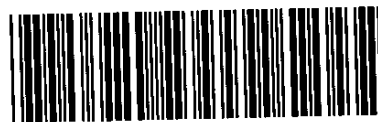
AND UPON READING the evidence

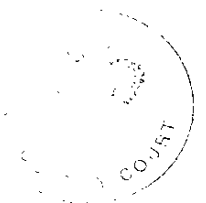
AND UPON the Claimant by his solicitors undertaking to:

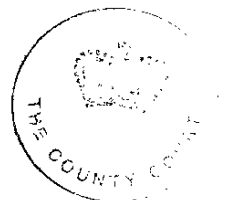
