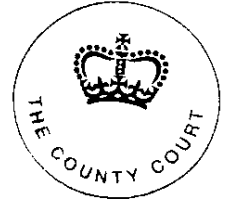

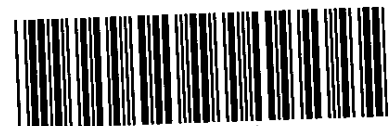
AND IT APPEARING that there is no opposition on behalf of Her Majesty to

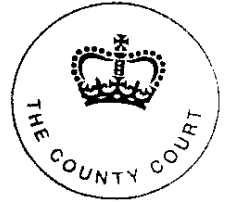

- (5) the hearing fixed for the 30<sup>th</sup> April 2020 be vacated

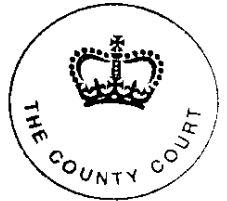
