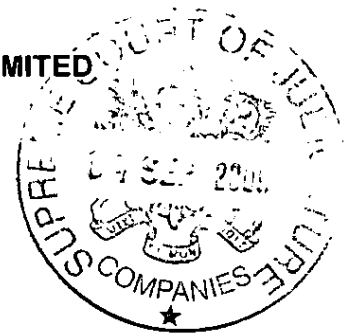

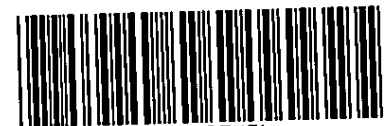

(5) the hearing fixed for the 27th November 2009 be vacated

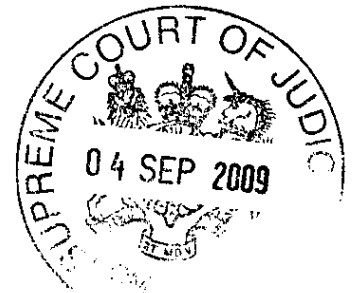
