Directors' report for the year ended 31 December 2022

The directors present their report and financial statements of Kangaroo Ridge Wines Europe Limited (the "Company") for the year ended 31 December 2022.

Review of the business and principal activities

The Company was dormant for the year ended 31 December 2022 and the directors do not expect the Company to commence trading in the foreseeable future.

The Company's result for the year ended 31 December 2022 amounted to £ nil (year ended 31 December 2021: £ nil). No dividends were paid during the year ended 31 December 2022 (year ended 31 December 2021: £ nil).

The Company has been dormant within the meaning of section 1169 of the Companies Act 2006 (the "Act") throughout the year ended 31 December 2022 and the directors have resolved to take advantage of the exemption conferred by section 480 of the Act. The directors are responsible for preparing the Directors' report and the financial statements in accordance with applicable law and regulations.

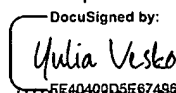

They are also responsible for safeguarding the assets of the Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Notes to the financial statements for the year ended 31 December 2022

1. General information

The Company is a private company limited by shares and is incorporated and domiciled in England and Wales under the Companies Act 2006. The address of its registered office is: Bureau, 90 Fetter Lane, London, EC4A 1EN.

2. Accounting policies

The principal accounting policies are summarized below. They have all been applied consistently throughout the current and preceding year.

2.1. Statement of compliance

The financial statements of the Company have been prepared in accordance with Financial Reporting Standard 101, "Reduced Disclosure Framework" ("FRS 101") and the requirements of the Companies Act 2006.

2.2. Basis of preparation

The financial statements have been prepared under the historical cost convention.

The financial statements are presented in the Pound Sterling, which is the functional currency of the Company.

The Company's ultimate parent undertaking, Anheuser-Busch InBev SA/NV includes the Company in its consolidated financial statements. The consolidated financial statements of Anheuser-Busch InBev SA/NV are prepared in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standard Board ("IASB") and in conformity with IFRS as adopted by the European Union, and may be obtained from the Corporate Secretary at Anheuser-Busch InBev SA/NV, Brouwerijplein 1, B-3000 Leuven, Belgium.

2.3. Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new ordinary shares are shown in equity as a deduction, net of tax, from the proceeds.

4. Ultimate parent undertaking

The immediate parent undertakings as at 31 December 2022 were Brewman Group Limited and FBG Treasury (UK) Limited, companies that are both incorporated in England and Wales.

At 31 December 2022 the ultimate parent undertaking and controlling party was Anheuser Busch InBev SA/NV, a company incorporated in Leuven, Belgium. Anheuser Busch InBev SA/NV is the parent undertaking of the smallest and largest group to consolidate these financial statements.
