

"Deed of Grant" means the lottery funding deed dated 17 August 2001 between the Company and the Lender as amended, supplemented, replaced and/or restated from time to time and notwithstanding any changes to or increase in the principal amount of the grant made available to Hampshire Cricket Limited;

"Deed of Settlement and Variation" means the deed of settlement and variation between Hampshire Cricket Limited, Rose Bowl PLC and the Lender dated 1 October 2009;
