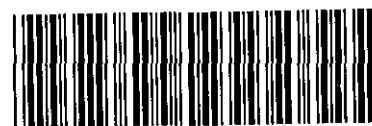

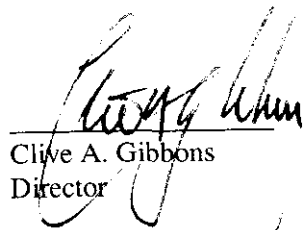

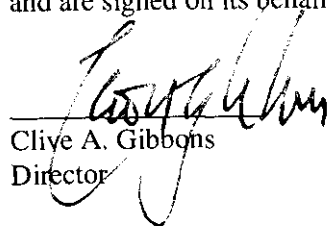
The Company did not trade during the current financial year or the preceding financial period and has made neither a profit nor loss, nor any other recognised gain or loss.
