26 January 2018

**Between:**

- (1) **Hall & Woodhouse Limited**, a company incorporated in England and Wales with registered number 00057696 (the "**Company**"); and
- (2) **Barclays Bank PLC** (the "**Security Agent**") as agent and trustee for the Secured Parties (as defined in the Common Terms Agreement defined below).

**Background:**

- (A) Pursuant to the Original Debenture (as defined below), the Company created Security over all of its assets in favour of the Security Agent.
- (B) It has now been agreed to amend the Facility Letter to extend the facilities made available thereunder.
- (C) It is a condition to the availability of the facilities under the Amended Facility Letter that the Company enters into this Supplemental Debenture (this "**Deed**") and the board of directors of the Company are satisfied that it is in the interests of the Company to enter into this Deed and the Company has passed a resolution to that effect.

**It is agreed as follows:**

**1. DEFINITIONS AND INTERPRETATION**

**1.1 Definitions**

Unless otherwise defined in this Deed, terms defined in the Original Debenture shall have the same meanings when used in this Deed and the following expressions shall have the following meanings:

**"Amended Facility Letter"** means the Facility Letter, as amended and restated by an amendment and restatement agreement entered into on or about the date of this Deed between the parties to the Facility Letter.

**"CTA"** means the common terms agreement originally dated 8 March 2011 and as amended and restated on 18 December 2013 and further amended and restated on 6 February 2015 and made between (1) the Company (2) the Guarantors (3) the financial institutions as Lenders (4) Barclays Bank PLC as Agent and (5) Barclays Bank PLC as Security Agent and Barclays Bank PLC and Lloyds Bank plc as Hedge Counterparties (each term as defined therein) (as further amended, restated or supplemented from time to time).

**"Facility Letter"** means the amended and restated facility letter dated as of 6 February 2015 and made between (1) Hall & Woodhouse Limited and (2) Barclays Bank PLC, as amended.

**"Finance Documents"** means the Finance Documents as defined in the CTA, and includes without limitation the Amended Facility Letter.

**"Original Debenture"** means the debenture originally entered into between (1) the Company, (2) Woodhouse Inns Limited and (3) the Security Agent dated 8 March 2011 as supplemented from time to time.

**"Scheduled Properties"** means all the property short particulars of which are set out in the

Schedule to this Deed, including in each case, without limitation, all Fixtures on such property, all proceeds and rights of sale and insurance derived from such property and the benefit of all covenants to which the relevant Company is entitled in respect of such property, all of which are now or at any time after the date of this Debenture become the property of the Company.

**"Secured Liabilities"** mean all money, debts, obligations and liabilities from time to time due, owing or incurred by the Company to any Secured Party or their assignee or successor on any current or other account whatever or otherwise in any manner whatever, in each case under each Finance Document to which such Company is a party, as amended, varied, restated, supplemented, substituted, replaced or novated (whether present or future, whether alone or jointly with any other person, whether actual or contingent, whether as principal or as surety, whether express or implied, in whatever name, form or style, in whatever currency it is denominated, or whether originally owing to the Secured Party or purchased or otherwise acquired by the Secured Party, its assignee or successor).

**"Secured Parties"** has the meaning given to such term in the CTA.

## 1.2 Construction

Unless a contrary intention appears, Clause 1.2 (*Construction*) of the Original Debenture applies to this Deed, and shall be deemed to be incorporated into this Deed, mutatis mutandis, as though set out in full in this Deed, with any reference to "this Deed" being deemed to be a reference to "this Deed", subject to any necessary changes.

## 2. SECURITY

### 2.1 General provisions

The Security created under this Deed:

- (a) is supplemental to the Security created under the Original Debenture;
- (b) is continuing security for the payment and discharge of the Secured Liabilities; and
- (c) is created in favour of the Security Agent as agent and trustee, and the Security Agent holds the benefit of this Deed on trust, for the Secured Parties.

### 2.2 Scheduled Property

The Company charges, with full title guarantee, by way of fixed charge, the Scheduled Property and all Rights relating to the Scheduled Property.

### 2.3 Contracts

The Company assigns, with full title guarantee, by way of fixed charge, the Contracts.

### 2.4 Book Debts

The Company charges, with full title guarantee, by way of fixed charge, the Book Debts.

### 2.5 Intellectual Property

- (a) The Company charges, with full title guarantee by way of fixed charge, all the Intellectual Property now or in the future owned, possessed or controlled by the Company (whether alone or with others) anywhere in the world.

- (b) The Company charges, with full title guarantee by way of fixed charge, the benefit of all agreements and licences now or in the future entered into or enjoyed by or on behalf of the Company relating to the use or exploitation by or on behalf of the Company anywhere in the world of any Intellectual Property owned by others.
- (c) The Company charges, with full title guarantee, by way of fixed charge, all the Company's rights now or in the future in relation to trade secrets, confidential information, and know how in any part of the world.

## **2.6 Plant and Machinery**

The Company charges, with full title guarantee, by way of fixed charge, the Plant and Machinery.

## **2.7 Securities and Derivative Assets**

- (a) The Company charges, with full title guarantee, by way of fixed charge, the Securities.
- (b) The Company charges, with full title guarantee, by way of fixed charge, all Derivative Assets of a capital nature.
- (c) The Company charges, with full title guarantee, by way of fixed charge, all Derivative Assets of an income nature.

## **2.8 Bank Accounts**

The Company charges, with full title guarantee, by way of fixed charge, all present and future bank accounts, cash at bank and credit balances of the Company (excluding those arising on fluctuating accounts) with any bank or other person and all rights relating to or attaching to them (including the right to interest).

## **2.9 Goodwill**

The Company charges, with full title guarantee, by way of fixed charge, all the goodwill and uncalled capital for the time being of the Company.

## **2.10 Insurance**

- (a) The Company charges, with full title guarantee, by way of fixed charge, all present and future insurances in respect of any Fixed Charge Assets and the proceeds of such insurances.
- (b) The Company charges, with full title guarantee, by way of fixed charge, all other present and future insurances and the proceeds of such insurances.
- (c) The Company charges, with full title guarantee, by way of fixed charge, the benefit of all warranties, instruments, guarantees, charges, pledges, and other security and all other rights and remedies available to the Company in respect of any Fixed Charge Asset.

## **2.11 Hedging Agreements**

The Company charges, with full title guarantee, by way of absolute legal assignment, the benefit of the Hedging Agreements.

## 2.12 **Accruals etc**

- (a) The Company charges, with full title guarantee, by way of absolute legal assignment, all rights, money or property accruing or payable to the Company now or in the future under or by virtue of a Fixed Charge Asset, except to the extent such rights, money or property are for the time being effectively charged under the provisions of Clauses 2.2 (*Scheduled Property*) to 2.11 (*Hedging Agreements*) (inclusive) (the "**Accruals**").
- (b) The Company charges, with full title guarantee, by way of fixed charge, the Company's rights now or hereafter to recover any VAT on any supplies made to it relating to the Assets any Tax refund, rebate or repayment, and any sums so recovered (the "**VAT Accruals**").

## 2.13 **Floating Charge**

- (a) The Company charges, with full title guarantee, by way of floating charge, all the undertaking and assets of the Company whatsoever, wherever situate, whether movable, immovable, present or future, including, without limitation, its uncalled capital for the time being and all the undertaking and assets of the Company referred to above which are, for any reason, not validly charged or assigned pursuant to Clauses 2.2 (*Scheduled Property*) to 2.12 (*Accruals etc*) (inclusive) of this Deed.
- (b) The floating charge created by this Deed is a qualifying floating charge for the purpose of paragraph 14 of Schedule B1 to the Insolvency Act.

2.14 The charges and assignments set out in Clauses 2.2 (*Scheduled Property*) to 2.12 (*Accruals etc*) are not intended to cover any Assets which are already charged to the Pension Schemes as at the date of this Deed.

2.15 The assignments set out in Clauses 2.11 (*Hedging Agreements*) and 2.12 (*Accruals etc*) are absolute assignments for the purposes of section 136 LPA and are not made by way of charge only.

## 2.16 **Financial Collateral**

To the extent that any part of the Assets constitute Financial Collateral and are subject to a Security Financial Collateral Arrangement created by or pursuant to this Deed, the Security Agent shall have the right, at any time after the Security constituted by this Deed become enforceable, to appropriate all or any part of those Assets in or towards the payment or discharge of the Secured Liabilities. The value of any Assets appropriated in accordance with this Clause 2.16 (*Financial Collateral*) shall be the price of those Assets at the time the right of appropriation is exercised as listed on any recognised market index, or determined by such other method as the Security Agent may select (including independent valuation). The Company agrees that the methods of valuation provided for in this Clause 2.16 (*Financial Collateral*) are commercially reasonable for the purposes of Regulation 18 of the Financial Collateral Regulations. To the extent that the Assets constitute Financial Collateral, the Company agrees that such Assets shall be held or designated so as to be under the control of the Security Agent for all purposes of the Financial Collateral Regulations.

## 3. **INCORPORATION**

The provisions of Clause 2 (*Covenant to pay*), Clause 3 (*Interest*) and Clauses 5 (*Conversion of Floating Charge*) to 40 (*Third Party Rights*) (inclusive) of the Original Debenture apply to this



Deed as though they were set out in full in this Deed except that references to "this Debenture" in the Original Debenture are to be construed as references to this Deed.

#### **4. CONTINUATION**

- 4.1 Except insofar as supplemental hereby, the Original Debenture will remain in full force and effect.
- 4.2 The Company agrees that the execution of this Deed shall in no way prejudice or affect the security granted by it (or the covenants given by it) under the Original Debenture.
- 4.3 References in the Original Debenture to "this Debenture" and expressions of similar import shall be deemed to be references to the Original Debenture as supplemented by this Deed and to this Deed.
- 4.4 This Deed is a Security Document and a Finance Document.

#### **5. GOVERNING LAW AND JURISDICTION**

##### **5.1 Governing law**

This Deed and any dispute, controversy, proceedings, claim or obligation of whatever nature arising out of or in any way relating to it, its subject matter or formation (whether contractual or non-contractual) is governed by and shall be construed in accordance with English law.

##### **5.2 Jurisdiction**

- (a) The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed (whether contractual or non-contractual) including a dispute regarding the existence, validity or termination of this Deed (a "**Dispute**").
- (b) The Security Agent and the Company agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly none of them will argue to the contrary.
- (c) This Clause 5.2 (*Jurisdiction*) is for the benefit of the Security Agent only. As a result, the Security Agent shall not be prevented from taking proceedings relating to a Dispute in any other courts with jurisdiction. To the extent allowed by law, the Security Agent may take concurrent proceedings in any number of jurisdictions.

##### **5.3 Freedom of Choice**

The submission to the jurisdiction of the courts referred to in Clause 5.2 (*Jurisdiction*) shall not (and shall not be construed so as to) limit the right of the Security Agent or any Secured Party to take proceedings against the Company in any other court of competent jurisdiction nor shall the taking of proceedings in any one or more jurisdictions preclude the taking of proceedings in any other jurisdiction (whether concurrently or not) if and to the extent permitted by applicable law.




