## Directors' report

The Directors present their annual report and the audited financial statements of Hall & Co. Limited ("the Company") for the year ended 31 July 2018.

The Company is a wholly owned subsidiary of its ultimate parent company Ferguson plc and operates as part of the UK business of the Ferguson plc group of companies (the "Group"). The Company did not trade during the current or prior year.

The Directors' report has been prepared in accordance with the special provisions relating to small companies under Section 415(A) of the Companies Act 2006 and consequently a separate Strategic Report is not presented.

#### Going concern

In the opinion of the Directors it is appropriate to draw up the financial statements on the going concern basis as the immediate parent company has given an undertaking to provide continued financial support for a period at least 12 months from the date on which these financial statements are signed.

#### **Future developments**

The Directors do not foresee, at the date of this report, that there will be any trade by the Company in the next year.

#### Results and dividends

The Company's profit for the financial year was £60,000 (2017: £684,000 loss). This was a result in the increase in the insurance receivable for asbestos related litigation, partially offset by an increase in the liability. The Directors do not recommend the payment of a dividend (2017: £nil).

#### Post balance sheet events

There have been no significant events since the balance sheet date.

#### Principal risks and uncertainties

Given the nature of the Company, there are no material risks and uncertainties facing the Company.

## 1 Accounting policies

The principal accounting policies are summarised below. They have all been applied consistently throughout the year and to the preceding year.

#### General information and basis of accounting

Hall & Co. Limited is a private company limited by shares incorporated in the United Kingdom under the Companies Act 2006 and is registered in England and Wales. The address of the registered office is given on page 1.

The financial statements have been prepared under the historical cost convention and in accordance with The Financial Reporting Standard 102 applicable in the UK and Republic of Ireland (FRS 102) issued by the Financial Reporting Council.

The functional and presentational currency of Hall & Co. Limited is considered to be pounds sterling because that is the currency of the primary economic environment in which the Company operates.

Hall & Co. Limited meets the definition of a qualifying entity under FRS 102 and has therefore taken advantage of the disclosure exemptions available to it in respect of its separate financial statements. Hall & Co. Limited is consolidated in the financial statements of its ultimate parent, Ferguson plc, which may be obtained from The Group Company Secretary, Ferguson plc, Grafenauweg 10, CH-6301 Zug, Switzerland. Exemptions have been taken in these separate company financial statements in relation to financial instruments, intragroup related party transactions, presentation of a cash flow statement and remuneration of key management personnel.

#### Going concern

The Directors have received a letter of support from the Company's immediate parent company, Wolseley UK Limited, which confirms that Wolseley UK Limited will provide such financial support as is necessary for the Company to meet its debts as they fall due for a period of not less than 12 months from the date on which the financial statements are approved by the Directors. Based on the ability of Wolseley UK Limited to provide this support and after having taken account of the principal risks and uncertainties as set out in the Directors report the Directors have concluded that it is appropriate to prepare the financial statements on a going concern basis.

#### Other operating income/ (costs)

Other operating costs comprises of movements in the provision recognised in relation to asbestos litigation and movements in the associated insurance receivable. These are recognised based on the review of Company asbestos liabilities advised by a third party actuary.

#### Taxation

Current tax, including UK corporation tax and foreign tax, is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

Current tax assets and liabilities are offset only when there is a legally enforceable right to set off the amounts and the Company intends either to settle on a net basis or to realise the asset and settle the liability simultaneously.

## 1 Accounting policies (continued)

#### **Provisions**

Provisions are recognised when the Company has a present obligation as a result of a past event, it is more likely than not that an outflow of resources will be required to settle the obligation, and the amount can be reliably estimated.

#### Critical accounting judgements and key sources of estimation uncertainty

Due to the nature of the Company there are no critical accounting judgements or key sources of estimation uncertainty that the Directors have made in the process of applying the Company's accounting policies.

#### Financial assets and liabilities

Financial assets and financial liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument.

All financial assets and liabilities are initially measured at transaction price and, where applicable, are subsequently measured at amortised cost.

Financial assets and liabilities are only offset in the Balance sheet when, and only when there exists a legally enforceable right to set off the recognised amounts and the Company intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Financial assets are derecognised when and only when a) the contractual rights to the cash flows from the financial asset expire or are settled, b) the Company transfers to another party substantially all of the risks and rewards of ownership of the financial asset, or c) the Company, despite having retained some, but not all, significant risks and rewards of ownership, has transferred control of the asset to another party.

Financial liabilities are derecognised only when the obligation specified in the contract is discharged, cancelled or expires.

#### 2 Auditor's remuneration

Audit fees for the Company for the year ended 31 July 2018 and year ended 31 July 2017 in relation to the auditing of the financial statements were borne by the immediate parent undertaking, Wolseley UK Limited. During the current and previous year Wolseley UK Limited paid £1,000 on behalf of the Company.

Fees payable to auditor and their associates for non-audit services to the Company are not required to be disclosed because the consolidated financial statements of the parent company are required to disclose such fees on a consolidated basis.

## 3 Employees and directors

There were no employees of the Company in either the current or previous year.

During the year ended 31 July 2018 and the year ended 31 July 2017, the emoluments of E L Hancox were paid by and disclosed in the financial statements of the immediate parent Company Wolseley UK Limited, which makes no recharge to the Company
