

12. (1) It shall be the duty of a Company within three months after the commencement of this Act to send to the Registrar for registration a Statement of the total amount outstanding at the commencement of this Act of the Debts of the Company secured by Mortgages or Charges created before the commencement of this Act, which under the provisions of this Act would have required registration had they been created after the commencement of this Act, except those already required to be registered under Section 14 of The Companies Act, 1900, and the Registrar shall, on payment of the prescribed fee, enter those particulars on the Register of Mortgages and Charges:

Provided that the neglect of the Company to comply with the provisions of this sub-section shall not prejudice the rights under any such Mortgage or Charge of any person in whose favour the Mortgage or Charge was made.

(2) If the Company fail to comply with the requirements of this Section the Company, and every Director, Manager. Secretary, or other person who is knowingly a party to the default, shall on conviction be liable to a fine not exceeding fifty pounds for every day during which the default continues.
