- (3) an Office Copy of the Order be delivered to the Registrar of
 Companies and pursuant to the above mentioned Act 122634 Plc
 is thereupon to be deemed to have continued in existence as if its
 name had not been struck off

- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) in the event that the Claimant fails to comply with undertaking (C) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimant
- (6) the hearing fixed for the 5 November 2010 at 2 00 pm be vacated
- (7) the Application Notice issued herein on the 16 August 2010 be fixed with a time estimate of 30 minutes, to determine the issue under Section 1032(3) of the Companies Act 2006 that the time between the company's dissolution and any Order not count for

limitation purposes
