NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, effective as of June 21, 2022 (this "Notice") is made by C. & J. CLARK INTERNATIONAL LIMITED, a company incorporated in England and Wales with registered office at 40 High Street, Street, Somerset, BA16 0EQ and with registered number 00141015, C. & J. CLARK AMERICA, INC., a Pennsylvania corporation, C. & J. CLARK RETAIL, INC., a Pennsylvania corporation and CLARKS AMERICAS INC., a Delaware corporation and C. & J. CLARK (HOLDINGS) LIMITED, a company incorporated in England and Wales with registered office at 40 High Street, Street, Somerset, BA16 0EQ and with registered number 00079142 (each, a "Grantor" and collectively, the "Grantors"), in favor of BANK OF AMERICA, N.A., as agent and security trustee (the "Agent") for its own benefit and the benefit of the other Secured Parties (as defined in the Intercreditor Agreement), in consideration of the mutual covenants contained herein and benefits to be derived herefrom.

WITNESSETH:

WHEREAS, Grantors are party to that certain Security Agreement, dated as of June 21, 2022, by the Grantors in favor of the Agent, for the benefit of the Agent and the Secured Parties (as amended, restated, amended and restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors have executed and delivered this Notice for the purpose of recording and confirming the grant of the security interest of the Agent in the Intellectual Property Collateral (as defined below) with the United States Patent and Trademark Office and the United States Copyright Office, as applicable;

NOW, THEREFORE, in consideration of the mutual conditions and agreements set forth herein and in the Security Agreement, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Grantors and the Agent, on its own behalf and on behalf of the other Secured Parties (and each of their respective successors or assigns), hereby agree as follows:

SECTION 1. <u>Defined Terms</u>. Unless otherwise defined herein, terms defined in the Security Agreement, and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest. In furtherance and as confirmation of the Security Interest granted by the Grantors to the Agent (for its own benefit and the benefit of the other Secured Parties) under the Security Agreement, and as further security for the payment or performance, as the case may be, in full of the Secured Obligations, each Grantor hereby ratifies such Security Interest and grants to the Agent (for its own benefit and the benefit of the other Secured Parties) a continuing security interest, in all of the present and future right, title and interest of each Grantor in, to and under the following property, and each item thereof, whether now owned or existing or hereafter acquired or arising, together with all products, proceeds, substitutions, and accessions of or to any of the following property (collectively, the "Intellectual Property Collateral"):

- (a) All trademarks, trade names, corporate names, company names, Internet domain names, business names, fictitious business names, trade dress, trade styles, service marks, designs, logos and other source or business identifiers, whether registered or unregistered, together with all registrations thereof, all applications in connection therewith and all renewals thereof, and any goodwill of the business connected with, and symbolized by, any of the foregoing, including, without limitation, the trademark registrations and trademark applications set forth on Exhibit A attached hereto (collectively, "Trademarks");
- (b) All patents and applications for patents, and the inventions and improvements therein disclosed, and any and all divisions, revisions, reissues and continuations, continuations-in-part, extensions, and reexaminations of said patents, including, without limitation, the patents and patent applications set forth on Exhibit B attached hereto (collectively, "Patents");
- (c) All copyrights and like protections in each work of authorship or derivative work thereof, whether registered or unregistered and whether published or unpublished, including without limitation the registrations and applications set forth on Exhibit C attached hereto, and all renewals thereof (collectively, "Copyrights");
- (d) All agreements, whether written or oral, providing for the grant by or to any Grantor of any right in respect of any Trademark, Patent or Copyright (collectively, "<u>Licenses</u>") and all income, royalties, damages and payments now and hereafter due and/or payable under and with respect to the Trademarks, Patents and Copyrights, including, without limitation, payments under all Licenses entered into in connection therewith and damages and payments for past or future infringements, misappropriations or dilutions thereof;
- (e) The right to sue for past, present and future infringements, misappropriations and dilutions of any of the Trademarks, Patents and Copyrights; and
- (f) All of the Grantors' rights corresponding to any of the foregoing throughout the world.

Notwithstanding the foregoing, no Trademark shall be included in the Intellectual Property Collateral to the extent that the grant of a security interest in such Trademark would result in, permit or provide grounds for the cancellation or invalidation of such Trademark.

Notwithstanding anything to the contrary contained in clauses (a) through (f) above, the security interest created by this Notice shall not extend to, and the term Intellectual Property Collateral shall not include, any Excluded Property. The Grantors shall from time to time at the request of the Agent give written notice to the Agent identifying in reasonable detail the Excluded Property and shall provide to the Agent such other information regarding the Excluded Property as the Agent may reasonably request.

SECTION 3. <u>Intent</u>. This Notice is being executed and delivered by the Grantor for the purpose of recording and confirming the grant of the security interest of the Agent in the Intellectual Property Collateral with the United States Patent and Trademark Office and United

States Copyright Office, as applicable. It is intended that the security interest granted pursuant to this Notice is granted in conjunction with, and not in addition to or limitation of, the Security Interest granted to the Agent, for its own benefit and the benefit of the other Secured Parties, under the Security Agreement. All provisions of the Security Agreement shall apply to the Intellectual Property Collateral. The Agent shall have the same rights, remedies, powers, privileges and discretions with respect to the security interests created in the Intellectual Property Collateral as in all other Collateral. In the event of a conflict between this Notice and the Security Agreement, the terms of the Security Agreement shall control.

SECTION 4. <u>Recordation</u>. The Grantors authorize and request that the Commissioner for Patents and the Commissioner for Trademarks or Register of Copyrights, as applicable, and any other applicable government officer record this Notice.

SECTION 5. <u>Termination</u>; <u>Release of Intellectual Property Collateral</u>. Upon termination of the Security Interest in the Intellectual Property Collateral in accordance with the Security Agreement, the Agent shall execute, acknowledge, and deliver to the Grantors, an instrument in writing in recordable form releasing the collateral pledge, grant, lien and security interest in the Intellectual Property Collateral under this Notice. Any execution and delivery of termination statements, releases or other documents pursuant to this SECTION 5 shall be without recourse to, or warranty by, the Agent or any other Secured Party.
