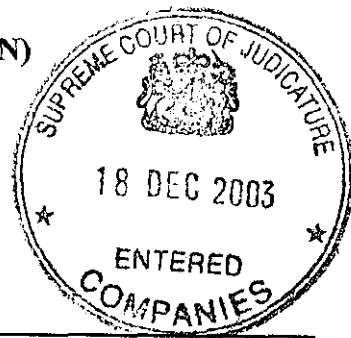

UPON THE PETITION of SJP (UK) Limited (in administration) (the "Company") by its administrators Simon Vincent Freakley and Alastair Paul Beveridge of Kroll Limited, ("Kroll"), 10 Fleet Place, London, EC4M 7RB (the "Joint Administrators")

AND UPON HEARING Counsel for the Company

AND UPON READING the documents recorded on the Court files as having been read

IT IS ORDERED AND DIRECTED THAT

- (1) the Administration Order dated 11 July 2002 and extended on 11th March 2003 and 22nd October 2003 be and is hereby discharged pursuant to section 18 of the Insolvency Act 1986;
- (2) advertisement of the Petition to wind up the Company be dispensed with;
- (3) the Company be wound up by the Court under the provisions of the Insolvency Act 1986;

- (4) the Joint Administrators be released as Joint Administrators pursuant to section 20 of the Insolvency Act 1986 28 days after the filing of their final receipts and payments account pursuant to rule 2.52 of the Insolvency Rules 1986;
- (5) the costs of the Petition be costs in the Administration and paid as such out of the Company's assets
