#### 1. Introduction

1.1 Malcolm Edward Fergusson of Fergusson & Co Ltd, 12 Halegrove Court, Cygnet Drive, Stockton on Tees, TS18 3DB was appointed Liquidator of the Company on 24 April 2018.

- 1.2 The purpose of the Final Account is to summarise the winding-up as a whole and to set out details of the Liquidator's acts and dealings.
- 1.3 For information, the Liquidator is required to meet a considerable number of statutory and regulatory obligations. Whilst many of these tasks do not have a direct benefit, they assist in the efficient and compliant progressing of the Liquidation, which ensures that the Liquidator and his staff are able to carry out their work to high professional standards. The narrative detail in respect of these tasks may be found at Appendix 3.

#### 2. Company Background

2.1 The Company was incorporated on 9 April 1920 and prior to ceasing to trade carried on business as a manufacturer of monitoring equipment. The Company has been dormant for approximately 10 years.

#### 3. Assets Realised and Amounts Distributed to the Member

#### 4. Receipts and Payments Account

4.1 A copy of the Liquidator's receipts and payments account for the period from 24 April 2018 to 27 September 2018 is enclosed at Appendix 1. This account has been reconciled to the Liquidation bank account and balances to nil.

#### 5. Creditors

5.1 The Liquidator advertised for creditors' claims shortly after his appointment; however, no claims were received by the deadline. A compensation claim for noise induced hearing loss was received after the deadline which has been passed to the Company's insurers.

#### 6. Liquidator's Remuneration

6.1 At the General Meeting held on 24 April 2018 the member passed the following resolution:

"That the Liquidator shall be authorised to draw his remuneration based upon his time costs by reference to the time properly given by the Liquidator and his staff in attending to matters arising in the liquidation at Fergusson & Co Ltd's standard hourly rates, prevailing at the time the work is done capped at £5,000.00, plus VAT and disbursements."

- 6.2 The total time spent following Mr Fergusson's appointment as Liquidator equates to £5,183.50 representing 30.70 hours at an overall average of £168.84 per hour.
- 6.3 The hourly charge out rates applicable in this case are as follows:

6.4 The costs and expenses of the Liquidation have been settled by Endress+Hauser Investments Limited, the sole shareholder.

6.5 In addition, to the costs of Liquidation, Fergusson & Co Ltd had pre-Liquidation costs of £1,657.00, which are not being charged for.
