

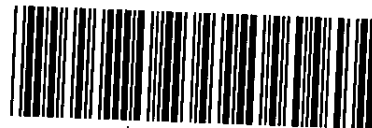

ORDER

*Before District Judge Khan*  
UPON THE APPLICATION dated *28th August 2018*

AND UPON READING the Witness statement of Howard Smith dated *28th August 2018*

IT IS ORDERED THAT:

1. Such of the insolvency proceedings set out in the attached Schedules that are proceeding in any Court other than this Court be transferred to this Court for the purposes of this Application and thereafter be transferred back to that Court.
2. Pursuant to sections 13 and 19 and paragraphs 63, 88, 91 and 95 of Schedule B1 to the Insolvency Act 1986 (the **Act**) and rule 12.36 of the Insolvency (England and Wales) Rules 2016 (the **Rules**):
  - (a) Jonathan Charles Marston be removed from office as Administrator of the companies listed in Schedule 1 and James Ronald Alexander Lumb be appointed as Administrator of those companies; and

- (b) James Ronald Alexander Lumb be appointed as Liquidator of those companies listed in Schedule 1 in the event that those administrations convert to Creditors' Voluntary Liquidations.
- 3. Pursuant to section 108 of the Act and rule 12.36(2) of the Rules:
  - (a) Jonathan Charles Marston be removed from office as Liquidator of the companies listed in Schedule 2 and James Ronald Alexander Lumb be appointed as Liquidator of those companies.
- 4. Pursuant to section 7(5) and paragraph 39(6) of Schedule A1 of the Act and rule 12.36 of the Rules:
  - (a) Jonathan Charles Marston be removed from office as Supervisor of the companies in Schedule 3 and James Ronald Alexander Lumb be appointed as Supervisor of those companies.
- 5. That in the case of each company identified in the Schedules the officeholder appointed or continuing in office, (as identified in those Schedules) will cause notice of the change in office holders to be:
  - (a) given to the Secretary of State for Business, Energy and Industrial Strategy within 14 days of the date of this order;
  - (b) advertised in the London Gazette or other appropriate publication within 14 days of the date of this order, such advertisement to include an explanation of the effect of the order and notice that any creditor may within 28 days of the advertisement of the order make an application to Court to challenge the order; and
  - (c) included in their next written report to creditors of the estates listed in the Schedules.
- 6. Pursuant to paragraph 98(2)(c) of Schedule B1 of the Insolvency Act 1986, the Second Applicant be discharged from liability in respect of his actions as Administrator of the companies listed in Schedule 1:
  - (i) If no application is made pursuant to paragraph 9 below, on the date being 28 days from the date of the advertisement referred to in paragraph 5(b) above, or
  - (ii) If an application is made pursuant to paragraph 9 below, at such time as should be *subsequently ordered by the Court*.

7. The Second Applicant shall receive his release (pursuant to s173(2)(b) and s174(4)(b) of the Insolvency Act 1986) as Joint Liquidator of the companies listed in Schedule 2, 28 days from the date of the advertisement referred to in paragraph 5(b), save that such release may be subject to further order in the event of an application by any creditor under paragraph 9 of this order for the specific case subject to that application.
8. Pursuant to Rule 12.10 of the Rules the need to serve the Application upon the Respondent be dispensed with.
9. There be liberty for each creditor or member of the companies listed in the attached Schedules to apply to vary or discharge this Order in so far as it relates to a company of which that person is a creditor or member within 28 days of the publication of an advertisement in relation to that company in accordance with paragraph 5(b) above.
10. There be no order as to costs.
11. Such further order or relief as the Court shall deem fit.
12. The Applicant has permission to apply.
