#### 1 Introduction and Statutory Information

- 1.1 On 26 March 2021, Derek Hyslop and Colin Dempster of EY Partheon LLP, 1 More London Place, London, SE1 2AF, United Kingdom (the "Previous Liquidators"), were appointed as Joint Liquidators of the following companies:

- 1.5 This report provides an update on the progress in the liquidation for year ended 25 March 2024 (the "Period") and should be read in conjunction with our previous progress reports dated 26 April 2023 and 29 April 2022 (the "Previous Reports").

#### 2 Progress of the Liquidation

2.1 During the Period, we complied with certain statutory obligations under the Insolvency Act 1986 and other related legislation. This work included circulation of the annual progress report for the year ended 25 March 2023.

Intercompany Receivables

- 2.2 As disclosed in the Previous Reports, the Declarations of Solvency for each of the Companies excluding City Tote Limited, disclosed Intercompany Receivables due from other members of the William Hill Group. The Declaration of Solvency of City Tote Limited showed no assets.
- 2.3 To date, there have been no realisations of intercompany receivables on any of the Companies and it is envisaged that these will be distributed in specie at the end of the liquidations.

HM Revenue & Customs Clearance

- 2.4 Within the Period, HM Revenue & Customs ("HMRC") issued pre-appointment clearance to close the liquidations of all the companies except for William Hill (strathclyde) Limited due to an outstanding penalty payment incurred for late filing of a pre-appointment corporation tax return submitted by the Company.
- 2.5 On 6 December 2023, HMRC advised that they would no longer provide pre- and post- tax clearances in members' voluntary liquidation (MVL) cases, effective from that date. In the absence of clearance being provided by HMRC, it may be necessary to request an indemnity from the member with respect to any potential liabilities arising in the future.

Lease

2.6 During the Period, we were informed that William Hill (strathclyde) Limited remains a party to a lease dated 23 February 2001. As the company is in liquidation, the Liquidators are instructing solicitors to take steps to serve notice of termination of the lease on the landlord of the property. Following discussions with the member, the costs of dealing with this, and any resulting claim, will continue to be dealt with by the member or other parts of the wider group.

#### 3 Creditors' Claims

- 3.1 The directors made Declarations of Solvency to the effect that all of the Companies' debts would be paid in full, together with statutory interest, within 12 months of the commencement of the Liquidation.
- 3.2 Whilst the directors were of the opinion that there were no creditors of the Companies, consideration was given to the possibility of potential claims.
- 3.3 A Notice to creditors to prove their debts was advertised in the London Gazette on 6 April 2021, and potential creditors were requested to deliver their proofs on or before 21 May 2021.

#### Secured Creditors

3.4 There are no unsatisfied charges registered at Companies House for any of the Companies.

#### **Preferential Creditors**

3.5 No preferential creditors' claims were anticipated, and none have been received.

#### **Unsecured Creditors**

3.6 No unsecured creditors' claims were anticipated, and none have been received.

#### 4 Distributions to Members

4.1 No distributions to members have been made for any of the Companies since the commencement of the liquidations.

#### 5 Joint Liquidators' Remuneration

- 5.1 The members approved that the basis of the Liquidators' remuneration be fixed by reference to the time properly spent by them and their staff in managing the liquidations.
- 5.2 The fee was agreed at £15,000 (in respect of the pre and post appointment time incurred in respect of the Companies) plus VAT and disbursements on the basis that the liquidations could be concluded within one calender year. As the liquidations did not conclude within one calender year, then a fixed fee of £750 per company plus VAT was also applied for each of the first and second years of the liquidations. A similar principle will apply for the third year of the liquidations.
- 5.3 Attached as Appendix A are separate Time Analyses providing details of the activity costs incurred by staff grade during this period in respect of the costs fixed by reference to time properly spent by us in managing the liquidations for each of the Companies.
- The total value of the time that we have incurred for the Period in respect of the Companies are £20,042. This represents 62.40 hours at an average rate of £321.19 per hour.
- Also attached as Appendix A are Cumulative Time Analyses for the period from the date of our appointment to 25 March 2024 which provides details of the total time costs incurred since the date of liquidation. Our total time costs for the Companies since the date of liquidation are £61,649.50, representing 197 hours at an average rate of £312.94 per hour.
- 5.6 Further discussions will need to be held with the shareholders in relation to additional time costs that have been incurred as a consequence of the extended period of time for which the liquidations have continued and out of scope work that it has been necessary to carry out during the liquidations to date.
- We can advise that since our last progress report on the liquidation dated 26 April 2023, we have been paid £11,253.18 and expenses of £3.18 plus VAT for the previous period.
- A contractual arrangement exists with a connected company in respect of the Liquidators' remuneration and as such the payment of such costs may not be made from the assets of the liquidation estates. Details of amounts paid, the name of the payor and the relationship between the payor and the Companies are available to shareholders upon request to the Liquidators at <a href="mail@rollingsbutt.com">mail@rollingsbutt.com</a>.
- 5.9 Attached as Appendix B is additional information in relation to the Liquidators' fees and expenses including where relevant, information on the use of subcontractors and professional advisers.

#### 6 Members' Rights

- 6.1 Within 21 days of the receipt of the report, members with either at least 5% of the total voting rights of all the members having the right to vote at general meetings of the company or with the permission of the court, may request in writing that the liquidators provide further information about their remuneration or expenses which have been itemised in the progress report.
- Any members with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the company may within 8 weeks of receipt of the progress report, make an application to court on the grounds that, in all the circumstances, the basis fixed for the liquidators' remuneration is inappropriate and/or the remuneration charged or the expenses incurred by the liquidators, as set out in the progress report, are excessive.

### 7 Next Report

7.1 We are required to provide a further report on the progress of the liquidation within six weeks of the end of the anniversary of the liquidation, unless we have concluded matters prior to this, in which case we will write again with our proposed final account.
