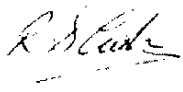

ORDER

UPON the application of Russell Stewart Cash ("Applicant") for a Block Transfer Order dated 20 August 2018

AND UPON READING the witness statement of the Applicant dated 20 August 2018 in support of the Application and the Respondents consenting to the Application

IT IS ORDERED that:

1. The cases listed in Schedules 1 -7 (attached to this order) ("**Block Transfer Cases**"), in so far as they may currently be proceedings in a County Court, or other Business and Property Court of the High Court of Justice, those proceedings be transferred to the Business and Property Courts in Manchester, solely for the purpose of making this order.
2. Immediately upon this order taking effect, each Block Transfer Case transferred to the Business and property Courts in Manchester pursuant to paragraph 1 above, be transferred back to the County Court or other Business and Property Court of the High Court of Justice.
3. The Applicant be removed from office in respect of each of the Block Transfer Cases from the date of this order.
4. Anthony Collier be appointed as joint replacement officeholder in respect of each of the cases listed in Schedule 2 from the date of this order.
5. Ben Woolrych be appointed as joint replacement officeholder in respect of each of the cases listed in Schedule 3 from the date of this order.
6. David Anthony Willis be appointed as joint replacement officeholder in respect of each of the cases listed in Schedule 4 from the date of this order.
7. John Anthony Lowe be appointed as joint replacement officeholder in respect of each of the cases listed in Schedule 5 from the date of this order.
8. Paul Andrew Whitwam be appointed as joint replacement officeholder in respect of each of the cases listed in Schedule 6 from the date of this order.
9. Steven Stokes be appointed as joint replacement officeholder in respect of each of the cases listed in Schedule 7 from the date of this order.

10. The creditors, or, in the case of any members' voluntary liquidation, any member, in each of the Block Transfer Cases be notified of this order by placing a block advertisement in the London Gazette within 28 days of the date of this order.
11. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies or persons listed in Schedules 1 to 7 who has an objection to this order shall have 28 days from the date of the advertisement in accordance with paragraph 10 to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases until further or other order by the court.
12. The replacement officeholders appointed pursuant to paragraphs 4 to 9 above shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidations and administrations listed Schedule 2 to 7 of the terms of this order as soon as reasonably practicable.
13. The Applicant shall file a copy of this order with each of the courts listed in Schedules 1 to 7.
14. Nothing in this order shall release the Applicant from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Schedules 1 to 7.
15. The Applicant shall:
 - (a) be at liberty to apply to the Secretary of State for his release from his position as:
 - (i) voluntary liquidator pursuant to section 173(2)(b)(ii) of the Insolvency Act 1986 ("Act);
 - (ii) liquidator of a company being wound up by the court pursuant to section 174(4)(b)(ii) of the Act; and
 - (b) receive his discharge as administrator pursuant to Paragraph 98(2)(c) of Schedule B1 of the Act;

14 days after filing notice of his removal with the Registrar of Companies in the case of any such appointments set out in Schedule 1 or the giving of notice to creditors in accordance with this order in any other of the Block Transfer Cases, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 11 of this order for the specific case subject to that application.

16. No order as to costs.
