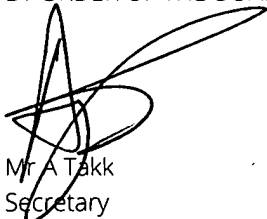
DIRECTORS' INTERESTS

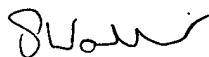
