The Directors do not recommend the payment of a dividend in respect of the year ended 31 December 2017 (2016: £nil).


#### Significant events since the end of the financial year

## Notes on the Financial Statements

### 1 Basis of preparation

---

#### (a) Compliance with International Financial Reporting Standards

The financial Statements of the Company have been prepared in accordance with International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board ('IASB'), including interpretations issued by the IFRS Interpretations Committee, and as endorsed by the European Union ('EU').

At 31 December 2017, there were no unendorsed standards effective for the year ended 31 December 2017 affecting these financial statements and the Company's application of IFRSs results in no differences between IFRSs as issued by the IASB and IFRSs as endorsed by the EU.

#### Standards adopted during the year ended 31 December 2017

There were no new standards applied during the year ended 31 December 2017. During 2017, the Company adopted a number of interpretations and amendments to standards which had an insignificant effect on the financial statements of the Company.

#### (b) Future accounting developments

At 31 December 2017, a number of standards, and amendments thereto, had been issued by the IASB, which are not effective for the Company's financial statements as at 31 December 2017. None of these are expected to have a significant effect on the results or net assets of the Company when adopted.

#### (c) General information

HSBC Global Custody Nominee (UK) Limited is a company domiciled and incorporated in England and Wales.

The functional currency of the Company is Sterling which is also the presentational currency of the financial statements of the Company.

The financial Statements have been prepared on the historical cost basis.

### 2 Directors' emoluments

The Directors did not receive any emoluments in respect of their services to the Company during the year. The Company has made no loans, guarantees or other such dealings to its directors and others during the year.

### 3 Related party transactions

---

There have been no transactions with related parties requiring disclosure in either the current or prior year. The Company is dormant and all statutory fees are paid by another group undertaking.

The ultimate parent undertaking (which is the ultimate controlling party) and the parent undertaking of the largest group of undertakings for which group financial statements are drawn up and of which the Company is a member is HSBC Holdings plc, and the parent undertaking of the smallest such group is HSBC Bank plc. The immediate holding company is HSBC Bank plc.
