- 2. THAT it would promote the success of the Company for the benefit of its members as a whole, and be to the further benefit and advantage of the Company to enter into the other Finance Documents to which it is a party (as defined in the New Facility Agreement).
- 3. THAT the Directors have authority to negotiate and approve the terms of, and the transactions contemplated by, the New Facility Agreement and the other Finance Documents (as defined in the New Facility Agreement) with such amendments as any authorised signatory or Director of the Company may in his or their sole discretion approve. The actions of the Directors in connection with the negotiation, execution, delivery and performance of the New Facility Agreement and the other Finance Documents (as defined in the New Facility Agreement) be and are hereby ratified.
- 4. THAT it would promote the success of the Company for the benefit of its members as a whole, and be to the further benefit and advantage of the Company to grant the guarantees as set out in the New Facility Agreement, and the Directors be and hereby are authorised to exercise all the powers of the Company to grant such guarantees.

- 1. The circulation date of the Resolutions is 22 February 2021. The Resolutions have been sent to eligible members who would have been entitled to vote on the Resolutions on this date. Only such eligible members (or persons duly authorised on their behalf) should sign the Resolutions.
- 2. An eligible member can signify his or its agreement to the Resolutions by signing and dating the Resolutions where indicated above and by either delivering a copy of the signed Resolutions to an officer of the Company by hand or by sending a copy of the signed Resolutions in hard copy form by post to the Company Secretary.
- 3. These Resolutions must be passed by the date falling 28 days after the circulation date. If these Resolutions are not passed by such date they will lapse. The agreement of a member to these Resolutions is ineffective if signified after this date.
- 4. A copy of these Resolutions has been sent to the auditors.
- 5. If you do not agree to the Resolutions, you do not need to do anything: you will not be deemed to agree if you fail to reply.
- 6. Once you have indicated your agreement to the Resolutions, you may not revoke your agreement.
- 7. In the case of joint holders of shares, only the vote of the senior holder who votes will be counted by the Company. Seniority is determined by the order in which the names of the joint holders appear in the register of members.
