- "An 'Intermediate Member' shall mean any member aged 22 to 25 years old inclusive"
- "A Social Member" shall mean any member with no playing privileges"

Resolution (3)

That existing Article 4 (proposed Article 5) be amended by adding the following - "In particular to provide facilities for and promote participation of the whole community in the game of golf"

Resolution (4)

That existing Article 7 (proposed Article 8) be amended as follows.-

- (I) By substituting "thirteen" for "fourteen"
- (II) By deleting "immediate Past Captain"
- (III) By adding the Honorary Treasurer as an ex-officio member of all Sub-Committees

Resolution (5)

That existing Article 12(d) (proposed Article 13(d)) be amended by substituting "three months" for "six months"

Resolution (6)

That existing Article 17(d) (proposed Article 18(d)) be amended by deleting the words "as to the payment or otherwise"
