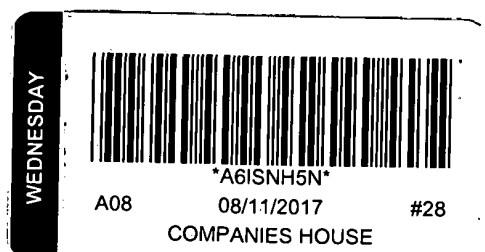

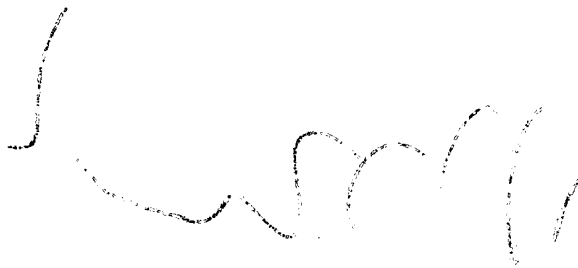
### AUDITORS

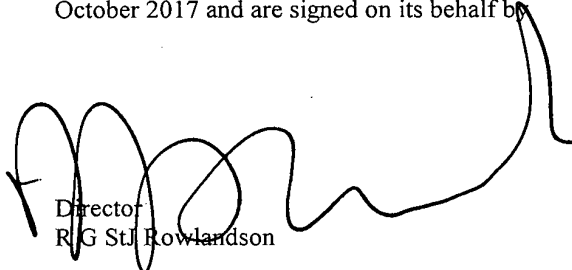
