




The following schedule details what I have sent you.

- 1. Fiche 1 details the shareholder register from 2 March 1997 to 5 December 1997. This fiche does not contain the dates of transfer, I have spoken to Lloyds Bank Registers and they have informed me that this format has been agreed with Companies House on the basis that members of the public can consult the register they hold at any prearranged time.
- 2. Fiche 2 & 3 details the shareholder register from 8 December 1997 to 16 December 1997 this fiche contains full transfer details.
- 3. On the 17 December all Grand Metropolitan Shareholders became shareholders in Diageo plc, with Diageo taking over 100% of the share capital of Grand Metropolitan plc, so on the 17 December 1998 Grand Metropolitan plc only had 1 shareholder.

Between 17 December 1997 and 2 March 1998 there have been a number of allotments of shares through Grand Metropolitan PLC's share schemes and that is what the schedules relate to. So all the people listed on the schedules became shareholders in Grand Metropolitan PLC on the date given on the schedules.
