# Notes forming part of the financial statements

### 1. Accounting policies

Basis for preparation of financial statements

These accounts are prepared under the historical cost convention and in accordance with the Companies Act 2006 and applicable UK accounting standards.

#### Investments

Fixed asset investments are stated at cost less provision for any impairment in value.

#### Consolidated financial statements

Group financial statements have not been prepared as the company is exempt from preparing and delivering group financial statements under section 400 of the Companies Act 2006 on the grounds that the company is a wholly owned subsidiary of Berendsen plc and the consolidated financial statements are publicly available.

#### 2. Investments

Shares in subsidiary undertakings are carried at cost. The carrying value at the beginning and end of the year is £4,539,144.

The company owns the whole issued share capital of Sunlight Service Group (Shop Investments) Limited, The Sunlight Group Limited, National Sunlight Laundries Limited, Fabricare Limited and Sunlight (72078) Limited: all those companies are incorporated in England.
