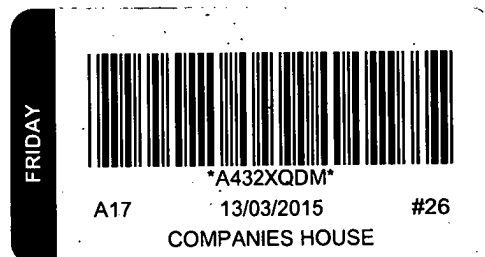

Trading results, dividends and transfer to reserves


There was no income for the current or the prior period and no transfer to reserves. No dividends were paid or proposed in either period.


