We are required to provide you with a final account on the conduct and outcome of the liquidation. This account is for the period 30 November 2017 to 13 August 2018 and also serves as a progress report from 30 November 2017 to 13 August 2018.

We are also required to give you certain information about the Company and the liquidators; this information is attached as Appendix A.

We attach as Appendix B a summary of our receipts and payments for the liquidation.

REPORT ON THE LIQUIDATION

Realisation of assets:

The directors' Declaration of Solvency showed that the Company had no surplus realisable assets.

No additional assets have been identified. There are no assets still to be realised.

Settlement of liabilities:

This section covers all liabilities except any claims of HM Revenue & Customs (HMRC) which are dealt with separately below under HMRC.

The directors' Declaration of Solvency and the Company's records showed the Company had no liabilities.

After our appointment we published a notice in the Gazette inviting any unknown creditors to send in their claims.

No such claims were received.

HMRC:

The directors' Declaration of Solvency and the Company's records showed that the Company had no tax liabilities.

After our appointment, we wrote to HMRC to inform them of our appointment and to request details of any outstanding liabilities. HMRC have confirmed that the Company has no outstanding liabilities and they have confirmed their agreement to us closing the liquidation.

Distributions to shareholders:

At the time of our appointment, the issued share capital of the Company consisted of 1 ordinary 25p share.

As there were no assets to distribute, a nil sweeper distribution comprising of any other assets was made. A notional value of $\pounds 1$ was attributed to the distribution to cover any assets arising in the future. The sweeper distribution provides the paperwork to transfer ownership of these back to the shareholder.

At the time of our appointment, a resolution was passed for us to be paid by reference to the time properly given by us and our staff in dealing with the liquidation.

Funding of the liquidation:

Although fees have been paid to us on the basis specified above, our fees and expenses have not been paid out of the liquidation estate. Instead, Lafarge Building Materials Limited has met our fees and expenses for the Company and 2 connected companies.

Remuneration charged:

Our fees for undertaking this assignment consist of time costs incurred for both (i) the period up to the day of our appointment and (ii) the period covering the formal liquidation. Our time costs for the period covering the formal liquidation were £10,118.

The above time costs for the liquidation period are calculated to 1 July 2018, being the latest practicable date. This represents 24.53 hours at an average hourly rate of £412.47

£ 16,796.05 has been invoiced for this case. A final invoice of £9,500 will be raised to conclude the liquidation.

During the liquidation we have incurred expenses of £1,188 plus VAT. These costs, which will be or have been re-charged, consist of:
