
- (1) the name of the above named Harlow and Milner Limited be restored to the Register of Companies

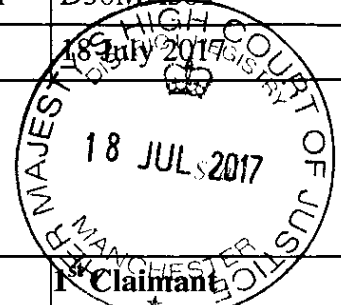
