The directors present their report and financial statements for the year ended 30 September 2009

Results and dividends

The company has not traded during the year and has made neither a profit nor a loss. No profit and loss account or statement of recognised gains or losses have therefore been prepared.

Review of the business

The company ceased to trade on 1 December 1992.

Risk and uncertainties

The company is not subject to any specific risks and uncertainties other than those prevalent in the music publishing market in general. All risks and uncertainties are regularly monitored by the company's board of directors.

Going concern

The directors believe that the company has adequate financial resources to continue in operation for the foreseeable future. The accounts have therefore been prepared on the going concern basis.

Directors and their interests

The directors of the company during the year ended 30 September 2009 were as listed on page 1.

Disclosure of information to the auditors

So far as each person who was a director at the date of approving this report is aware, there is no relevant audit information, being information needed by the auditor in connection with preparing its report, of which the auditor is unaware. Statement of directors' responsibilities

The directors are responsible for keeping proper accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. We have audited the financial statements of Chappell Music Limited for the year ended 30 September 2009 which comprise the Balance Sheet, and the related notes 1 to 8. In our opinion the information given in the Directors' Report for the financial year for which the financial statements are prepared is consistent with the financial statements.



1. Accounting policies

Basis of preparation

The financial statements are prepared under the historical cost convention and in accordance with applicable accounting standards

Accounting convention

Under an Exploitation Agreement dated 1 December 1992 Warner/Chappell Music International Limited, a fellow subsidiary undertaking, accepted the benefit and burden of the company's rights and obligations under its current and future contracts with third parties. Under the Exploitation Agreement the company's directors have the right to set an annual fee chargeable to Warner/Chappell Music International Limited. In the current year this fee was set at £nil (2008 – £nil)

Statement of cash flows

The company has taken advantage of the exemption in the Financial Reporting Standard No. 1 Revised (FRS1). A statement of cash flow has not been prepared because as at the year end, the company was a wholly owned subsidiary undertaking of WMG Acquisition Corp. Inc., a company incorporated in the United States of America, which prepares a group statement of cash flows.

2. Operating profit

The company has not traded during the year and has made neither a profit nor a loss. No profit and loss account has therefore been prepared.

Under the terms of the agreement entered into with Warner/Chappell Music International Limited dated 1 December 1992, Warner/Chappell Music International Limited is responsible for the payment of all costs and expenses of the company.

Audit fees of £300 have been borne by another group undertaking.
