The West of England Baptist Trust Company (East) Limited is a dormant company limited by guarantee, registered in England and Wales (No 367936) and registered as a charity (No 1091251) It is governed by its memorandum and articles of association

During the year 2010 in line with the strategic objective set in previous years, the business of the charity was merged into its sister company, the West of England Baptist Trust Company (West) Ltd (WEBTC(W)Ltd) Following this merger, there are no longer any assets but the company remains open as a dormant organisation for the time being. The charity is a subsidiary of the West of England Baptist Association (WEBA)

c Objectives and activities
