(B) Inform the Registrar of Companies immediately on the conclusion of the said litigation or any appeal therefrom or the conclusion of the claim by any other means

(C) Unless the said litigation is completed in the interim, at 6 monthly intervals from the date of the order serve on the Registrar of Companies a full and sufficient Witness Statement setting out what steps have been taken to progress the said litigation

(4) an Office Copy of the Order be delivered to the Registrar of Companies  
and pursuant to the above mentioned Act the Company is thereupon to  
be deemed to have continued in existence as if its name had not been  
struck off

(5) the Registrar of Companies do advertise notice of this Order in his official  
name in the "London Gazette"
