

Outstanding matters

As previously advised, the liquidators were notified of employer liability claims ("the Claims") against the Company. The Claims have been passed to the Company's insurers, who are currently investigating their validity. The insurers have advised that three of the five previously advised Claims have been finalised, however, a further two Claims were received during the year. The liquidation cannot be concluded until the remaining four Claims have been finalised.

Distributions

There were no distributions to shareholders during the course of the year.

Joint liquidators' remuneration and expenses

A written resolution was passed on 11 May 2010 that the remuneration of the joint liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.

In the event, the liquidators' remuneration has been paid by Bayer plc and accordingly no detailed analysis is included in this report.
