#### 1. ADMINISTRATORS' APPOINTMENT

Lynn Robert Bailey, Lindsey Jane Cooper and Simon Peter Bower of Baker Tilly Restructuring and Recovery LLP, St Philips Point, Temple Row, Birmingham, B2 5AF were appointed Joint Administrators ('Administrators') of Ivle Realisations Limited ("Ivle") (formerly Elvi Limited), Elvi Investments Limited ("Investments"), and Elvi Holdings Limited ("Holdings") ("the Companies" or "the Group") on 7 February 2008 by the directors of the Companies

The notices of appointment were filed in the Birmingham High Court of Justice under reference numbers 9057, 9058 and 9059 all of 2008

The Administrators' appointment specified that they would have power to act jointly and severally. The Administrators have exercised and will continue to exercise all of their functions jointly and severally as stated in the notice of appointment.

The Administrators are pleased to present their Proposals and Report pursuant to Paragraph 49 of the Insolvency Act 1986 (as amended) and Rule 2 33 of the Insolvency Rules 1986 (as amended)

## 2. STATUTORY INFORMATION

We attach as Appendix A an extract of statutory information, including details of the directors, company secretary and secured creditors from files held at Companies House Please note that the Registered Offices of the Companies were changed to c/o Baker Tilly Restructuring and Recovery LLP, St Philips Point, Temple Row, Birmingham, B2 5AF on 11 February 2008

# 3. EVENTS LEADING UP TO THE ADMINISTRATION

# Brief background

The business can be traced back to the 1940s and was originally started in Holland with the Elvi brand launched in the UK in 1993 aimed at the plus size market. A management buy out took place in 1997 and in 2006 a MBI was completed with backing from Langholm Capital.

Following the MBI the new management commenced a strategy to develop the brand and expand the retail operation through both concessions and direct outlets. In the year following the MBI the trading results for both Spring/Summer and Autumn/Winter seasons were poor which management consider was as a result of issues with the product range. As a consequence losses in excess of £1.5m were incurred. In December 2007 the major shareholder decided that they wanted to exit the business and instructed a firm of accountants to market the business through their corporate finance division. At the same time the Group's bankers withdrew facilities which led to severe cash flow difficulties.

Due to the cash flow constraints management undertook a focused marketing campaign with a number of parties expressing an interest in the business. On 17 January 2008 the shares and loan notes of approximately £825,000 issued as part of the MBI were acquired by Hillco who then injected approximately £200,000 into the business secured by fixed and floating charge debentures over the Companies. We understand that following a period of review Hillco decided not to invest further into the Companies and on 3 February 2008 their shareholding was sold to new investors who also took an assignment of the debentures and loan notes.

Upon acquisition the new investors instructed Baker Tilly to carry out an urgent assessment of the operations and the cash needs of the business. Accordingly following this review it was apparent that the Companies needed to seek protection from creditors and as a consequence the Directors appointed Administrators on 7 February 2008. We would point out that £10,000 has been charged to the new investors by Baker Tilly for this pre appointment work.

#### 4. STATEMENT OF AFFAIRS

Whilst the directors have not yet lodged the Statement of Affairs for each company with the Administrators these are expected to be available at the creditors' meetings. Accordingly, pursuant to Rule 2 33 of the Insolvency Rules 1986 (as amended), we attach an Estimated Statement of the Financial Position of the Companies as at 7 February 2008 as Appendix B.

The values at which creditors' claims are stated in the Estimated Financial Position are, as is required by legislation, those which are reflected in books and records of the Companies when we were appointed Accordingly it is our view that some balances may not be correct and certain claims may be subject to reduction in respect of mitigation, set-off or retention of title. The agreement of creditors' claims by the Administrators (or any subsequently appointed Supervisor or Liquidator) is a separate matter and will be dealt with as appropriate in due course, initially by reference to the Proofs of Debt lodged in the proceedings by creditors themselves

The 'Prescribed Part' is a statutory amount of each company's assets subject to a floating charge to be set aside for the benefit of non-preferential creditors. As the debentures referred to above were granted after September 2003 there will be a Prescribed Part available to non-preferential creditors.

The preferential claims for arrears of wages of approximately £125,000 have been settled via the purchaser and we have also dealt with sundry pre appointment deductions of approximately £5,000 which would also rank preferentially. However following the sale of the business all employees transferred to the purchaser and therefore no preferential claims in respect of accrued holiday pay are expected to arise

As advised above all monies fixed and floating charge debentures were granted in January 2008 being assigned in February this year. As also mentioned loan notes with a value of approximately £825,000 were also assigned to the same party and therefore legal advice is being sought as to whether this indebtedness is also caught by the security

In addition to the above mentioned security HSBC Bank plc ("the Bank") have a charge over the freehold premises in Redditch. The debt due to the Bank is approximately £1 6m and is due from Holdings with the charge granted by Ivle who own the freehold and provided a supported guarantee in respect of this indebtedness.

As mentioned below the Elvi trademark was owned by Investments who also hold a small number of the leaseholds and are due approximately £815,000 by Ivle. As regards Holdings its assets are two leaseholds, shareholding in Investments and an inter company debt of £1.7m due from Ivle.

## 5. CONDUCT OF THE ADMINISTRATION

Paragraph 3 to Schedule B1 to the Insolvency Act 1986 (as amended) sets out the purposes of an Administration The Administrator must perform his functions with the objective of

- (a) rescuing the company as a going concern, or
- (b) achieving a better result for the Company's creditors as a whole than would be likely if the company were wound up (without first being in Administration), or
- (c) realising property in order to make a distribution to one or more secured or preferential creditors

As advised above the business had been offered for sale in late 2007/early 2008 by the majority shareholder and we have been advised by management that no acceptable offers were received from any trade buyers. Accordingly we felt that a more public campaign should be undertaken to ascertain whether a going concern sale through Administration was possible and therefore placed an advertisement in the Financial Times on 8 February. Following this we received enquires from twenty interested parties to whom sale particulars were sent. In addition we contacted all parties who had previously expressed an interest in the business.

To enable a going concern sale to be explored we arranged for the Group's operations to continue and we maintained trading from all 28 leasehold stores and 63 concessions as well as the head office and distribution centre in Redditch with no redundancies declared at any location albeit an undertaking was given to staff that their wage arrears, which would rank preferentially, would be paid. This was made possible due to the cash flow generated through the retail operations and with funds in hand at our appointment of approximately £450,000. However it was apparent that trading would only be possible in the short term due to the level of current season stocks and the need to secure supplies for the remainder of the Spring/Summer period.

A number of interested parties visited the head office and met with management and the Administrators and competing offers were received for the business albeit one of these was not for the whole operation. Deadlines were set requesting these potential purchasers to make their best and final offer by 1pm on Friday 15 February following which an offer for the whole of the business and assets (excluding the freehold premises in Redditch and book debts) from GDCO 57 Limited ("GDCO") was accepted and the sale was completed the following day. The rationale for accepting GDCO's offer was the combination of the total consideration of £900,000, of which £300,000 was ascribed to the Elvi trade mark held by Investments, the transfer of all staff thus extinguishing any employee claims for redundancy etc and the assignment of all the leasehold properties which again would negate any claims from landlords. Accordingly with 28 leases and over 450 staff a combination of these claims would have increased the unsecured liabilities significantly

As referred to above both the freehold property and pre appointment book debts have been excluded from the sale. The freehold is being marketed by our agents, GVA Grimley and interested parties should contact Alistair Wright on 0121 609 8344. As regards the book debts these totalled approximately £600,000 at appointment and are due from the concession hosts. We have commenced collection of these debts and following the sale of the business we expect full recovery of the balances outstanding

Whilst none of the Group's directors were acting on behalf of GDCO at the time of the sale we understand that Oliver Spark and Simon Tutt have now been appointed as directors of that company. As part of the agreed transaction Elvi Limited has now changed its name to Ivle Realisations Limited with effect from 21 February 2008.

Accordingly whilst we have not been able to rescue the Companies as set out at (a) above we have been able to achieve purpose (b) being a better result than would have been achieved if the Companies had been placed into liquidation

We attach as Appendix C a summary of our receipts and payments for the Companies upon which we make the following comments

The proceeds from the sale of the business have been allocated in accordance with the consideration set out in the agreement with the main elements being approximately £580,000 in respect of stock, £300,000 relating to the Elvi trademark and £20,000 for plant and fixtures and fittings etc. The other main receipts relate to funds in hand, including credit card balances, of approximately £536,000 and post appointment trading of £203,169. We have also received approximately £131,500 on behalf of the purchaser which is held as third party funds

Payments since our appointment have been minimal although we have still to account to the purchaser for wages arrears, as referred to above We have also to deal with rent and other costs relating to our trading period. The current Group funds in hand are £1,861,291

# 6. MEETING OF CREDITORS

The Administrators have decided to convene separate meetings of creditors for each of the Companies, pursuant to paragraph 51 of Schedule B1 to the Insolvency Act 1986 (as amended)

The purpose of the meeting is for creditors to be able to consider the Administrators' proposals (section 7 below) and to ask questions as regards the conduct of the Administration. At the meeting, creditors are also entitled to establish a Creditors' Committee should they so wish, provided that there are no fewer than three and no more than five wishing to be represented on the committee.

## 7. ADMINISTRATORS' PROPOSALS

The Administrators' proposals in relation to each of the Companies are,

- 71 The Administrators should continue to realise the remaining assets upon the terms they consider to be the most beneficial to creditors of the Company
- 7 2 The Administrators should arrange to distribute available funds from the realised assets to those creditors entitled to them in such manner as they consider will lead to an early distribution of the available assets in an economic manner
- 7 3 The Administrators be authorised to make such application to Court for directions as they consider appropriate with a view to achieving the purposes of the Administration or their proposals
- In the event that a Creditors' Committee is not established, the Administrators shall be authorised to draw their remuneration based upon time costs incurred by them in the Administration, to be paid out of the assets of the Company in accordance with Rule 2 106(2) (b) by reference to the time properly given by the Administrators and their staff, in attending to matters arising in the Administration at Baker Tilly Restructuring and Recovery LLP standard hourly rates, current details of which are attached at Appendix H, but which are reviewed periodically

- In the event that a Creditors' Committee is not established, the Administrators shall be authorised to draw their disbursements and other expenses incurred by them in the Administration, to be paid out of the assets of the Company Such disbursements to include "Category 2 disbursements" at the rates disclosed in Appendix H to the proposals
- 7 6 The Administrators conclude the Administration when they consider appropriate and apply for their release from the Court
- 7 7 The Company exits the Administration by way of a Creditor's Voluntary Liquidation
- 7 8 That Lynn Robert Bailey and Lindsey Jane Cooper of Baker Tilly Restructuring and Recovery LLP of St Philips Point, Temple Row, Birmingham B2 5AF be appointed Joint Liquidators of the Company following the cessation of the Administration
- 7 9 To consider and if thought fit, appointing a Creditors' Committee to assist the Administrators
- 7 10 In the event that a Creditors' Committee is not established, the Administrators be discharged from liability in respect of any action of theirs as Administrators immediately following their cessation to act as Administrators

## 8. PROPOSED EXIT FROM ADMINISTRATION

It is proposed that each of the Companies shall exit Administration by entering into Creditor's Voluntary Liquidation

It is proposed that Lynn Robert Bailey and Lindsey Jane Cooper of Baker Tilly Restructuring and Recovery LLP , St Philips Point Temple Row, Birmingham B2 5AF be appointed Joint Liquidators of each of the Companies following the cessation of the Administration Creditors should note that they may nominate a different person as the proposed Liquidators, provided that the nomination is made after the receipt of the proposals and before the proposals are approved

# 9. DIVIDEND PROSPECTS

Based upon the Estimated Financial Position at appendix B there will be a Prescribed Part available for the unsecured creditors, which based upon the current estimate of total claims, would result in a dividend estimated in respect of lyle's creditors of approximately 5p in the pound before costs, accruing interest and post appointment taxation assuming that the loan notes are caught by the debenture. If this is not the case then the dividend would rise to an estimated 18p in the pound before costs, accruing interest and post appointment taxation. Both of these estimates take account of the inter company balances. However it is possible that Ivle may have a subrogated secured claim in Holdings relating to the freehold property thus negating all or part of the inter company dividend. Accordingly until all inter company debts are agreed it is not possible to estimate what dividend there would be to creditors of either Investments or Holdings.

## 10. ADMINISTRATORS' REMUNERATION

Creditors are asked to consider resolutions as regards the payment of the Administrators' remuneration and drawing certain disbursements from the Administration estate. These are detailed at paragraphs 7 4 and 7 5 of the Administrators' proposals. If a Creditors' Committee is appointed, it is for the Committee to consider this resolution.

Expenses and disbursements which are not capable of precise identification and calculation (for example any which include an element of shared or allocated costs) require approval prior to being drawn from the insolvency estate. These expenses are known as "Category 2" disbursements

This includes day-to-day administrative duties and dealing with statutory duties and responsibilities, including advertising notice of the Administration, providing notice to creditors, dealing with the submission of the Statement of Affairs and filing necessary documents at Companies House Other duties include handling and recording receipts and payments, VAT and Corporation Tax issues such as the monthly VAT returns, pension queries and general correspondence.

#### Realisation of Assets

Our staff have been assisting with various matters such as preparing sale documents, handling queries from interested parties and obtaining valuations of assets. A large amount of time has been spent on this area as it is considered to be a key aspect of the Administration Additionally, time has been spent reviewing Reservation of Title claims with regard to stock and dealing with Finance Company creditors.

# **Trading**

Our staff have had to set up accounts with suppliers in order to trade on an ongoing basis Payments to suppliers and general correspondence with these have been undertaken. Certain aspects of trading have led to large time demands upon our staff

#### Creditors

Queries from and correspondence with creditors and employees have been necessary aspects of the Administration process. The preparation of the Administrators' Proposals has been undertaken including the attendant aspects of providing and obtaining the required information, convening the creditors' meeting etc.

To date we have not drawn any amounts on account of our disbursements incurred

# **INSOLVENCY RULES 1986 (AS AMENDED)**

# Entitlement to vote (Rule 2.38)

- Subject as follows, at a meeting of creditors in administration proceedings a person is entitled to vote only if
  - a) he has given to the administrator, not later than 12 00 hours on the business day before the day fixed for the meeting, details in writing of the debt which
    - 1) he claims to be due to him from the company, or
    - in relation to a member State liquidator, is claimed to be due to creditors in proceedings in relation to which he holds office,
  - b) the claim has been duly admitted under the following provisions of this Rule, and
  - c) there has been lodged with the administrator any proxy which he intends to be used on his behalf,

and details of the debt must include any calculation for the purposes of Rules 2 40 to 2 42

- 2) The chairman of the meeting may allow a creditor to vote, notwithstanding that he has failed to comply with paragraph (1)(a), if satisfied that the failure was due to circumstances beyond the creditor's control
- 3) The chairman of the meeting may call for any document or other evidence to be produced to him, where he thinks it necessary for the purpose of substantiating the whole or any part of the claim
- 4) Votes are calculated according to the amount of a creditor's claim as at the date on which the company entered administration, less any payments that have been made to him after that date in respect of his claim and any adjustment by way of set-off in accordance with Rule 2 85 as if that Rule were applied on the date that the votes are counted
- A creditor shall not vote in respect of a debt for an unliquidated amount, or any debt whose value is not ascertained, except where the chairman agrees to put upon the debt an estimated minimum value for the purpose of entitlement to vote and admits the claim for that purpose
- 6) No vote shall be cast by virtue of a claim more than once on any resolution put to the meeting

- 7) Where
  - a) a creditor is entitled to vote under this Rule,
  - b) has lodged his claim in one or more sets of other proceedings, and
  - c) votes (either in person or by proxy) on a resolution put to the meeting, and
  - d) the member State liquidator casts a vote in respect of the same claim,
     only the creditor's vote shall be counted
- 8) Where
  - a) a creditor has lodged his claim in more than one set of other proceedings, and
  - b) more than one member State liquidator seeks to vote by virtue of that claim,

the entitlement to vote by virtue of that claim is exercisable by the member State liquidator in main proceedings, whether or not the creditor has lodged his claim in the main proceedings

- 9) For the purposes of paragraph (6), the claim of a creditor and of any member State liquidator in relation to the same debt are a single claim
- 10) For the purposes of paragraphs (7) and (8), "other proceedings" means main proceedings, secondary proceedings or territorial proceedings in another member State

# CHARGING, EXPENSES AND DISBURSEMENTS POLICY STATEMENT

# **Charging policy**

- Partners, directors, managers, administrators, cashiers, secretarial and support staff are allocated an hourly charge out rate which is reviewed from time to time
- Work undertaken by cashiers, secretarial and support staff will be or has been charged for separately and such work will not or has not also been charged for as part of the hourly rates charged by partners, directors, managers and administrative staff
- Time spent by partners and all staff in relation to the insolvency estate is charged to the estate
- Time is recorded in 6-minute units
- Time billed is subject to Value Added Tax (VAT) at the applicable rate (currently 17.5%)

# Expenses and disbursements policy

- Only expenses and disbursements properly incurred in relation to an insolvency estate are re-charged to the insolvency estate
- Expenses and disbursements which comprise external supplies of incidental services specifically identifiable to the insolvency estate require disclosure to creditors, but do not require creditors' approval prior to being drawn from the insolvency estate. These are known as "Category 1" disbursements
- Expenses and disbursements which are not capable of precise identification and calculation (for example any which include an element of shared or allocated costs) require the approval of creditors prior to be being drawn from the insolvency estate. These are known as "Category 2" disbursements
- General office overheads are not re-charged to the insolvency estate as a disbursement
- Any payments to outside parties in which the office holder or his firm or any associate has an interest will only be made with the approval of creditors
- Where applicable, expenses and disbursements re-charged to or incurred directly by an insolvency estate are subject to Value Added Tax (VAT) at the applicable rate (currently 17 5%)
