Sub-Hire Agreement Amendment Letter

We, Handelsbanken plc, ("We", "Us", the "Lender"), refer in this amendment letter (the "Amendment Letter") to the Hire Purchase Agreement to be entered into between You, A. Herring Limited ("You", the "Hirer") and Us, a d write to confirm the following amendments to the Agreement. Unless otherwise stated, terms defined in the Agreement have the same meaning herein.

Notwithstanding the provisions of Clause 7.10 of the Agreement the Lender hereby agrees that the Hirer shall be entitled to sub-hire or sub-lease all or any of the Goods subject to the Agreement in a form for the time being approved by the Lender for the purpose, to sub-hirers or sub-lessees of good repute at commercial rents but in that event:
