AND UPON READING the evidence

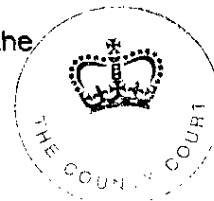
AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the waiver letter from the Treasury Solicitor dated the 24 July 2017

AND on leave being given to amend the Claim Form (i) to show the correct name of the Company as R.C.Glaze Properties Limited (ii) by joining Pineapple Corporation Plc a member of the Company and Anthony John Sperrin a director of the Company as the Second and Third co-Claimants and (iii) by removing the Treasury Solicitor as a Defendant and re-service being dispensed with

AND upon the Second and Third co-Claimants by their solicitors undertaking that:

(A) the Company will not carry on business or operate in any way other than to take the necessary steps to;

(i) transfer to Percy House Freehold (2014) Limited the Sliver of Land comprising a garden and passageway in Flat 2, Percy House, Sulgrave Road, London W5 7QE referred to in Paragraph 2 of the

and

(ii) settle all outstanding debts to its existing creditors, if any

(the actions) according to law

- (B) they will notify the Registrar of Companies immediately on the conclusion of the actions
- (C) the director of the company will immediately on the expiry of 3 months from the conclusion of the actions apply to the Registrar of Companies for the voluntary strike off of the company under Section 1003 of the Companies Act 2006 and comply with all the relevant requirements for such an application.

AND UPON the Solicitors/Claimants and the Registrar of Companies (the Defendant) consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named R.C. Glaze Properties Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 499927 Limited
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
