REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF TPIC (BIRMINGHAM) LIMITED

Opinion

We have audited the financial statements of TPIC (Birmingham) Limited (the 'company') for the year ended 31 July 2017 on pages five to six. Responsibilities of directors




