BACKGROUND

A resolution for Members Voluntary Liquidation was passed by the shareholders of A B Wilkinson(Farmers) Limited ("the Company") on 16th March 2012 and I was appointed Liquidator on that date I would also refer to my recently issued Annual Progress Report

RECEIPTS AND PAYMENTS ACCOUNT

I have pleasure in attaching my final Liquidator's Receipts & Payments Account, showing the realisations in the liquidation, together with the fees, costs and expenses that have been paid in the liquidation

ASSETS

The Declaration of Solvency dated 8th March 2012 indicated the company's assets to consist of the following

As previously reported these assets were distributed in specie in full to Mr J Wilkinson After taking into account the known liabilities of the company, the value of assets received by Mr Wilkinson exceeded his entitlement as a shareholder of the company

Mr Wilkinson repaid the sum of £200,000 to the company following the sale of the couple's jointly owned home This sum included £7,237 in settlement of his overdrawn director's loan account

Other realisations

The only other realisation in this matter has been in respect of a pre-liquidation VAT refund due to the company in the sum of £1,392

Conclusion

Assets realisations are complete No bank interest has been received on the funds in hand

LIABILITIES

Secured Liabilities

An examination of the company's mortgage register held by the Registrar of Companies showed that the company has not granted any debentures or other forms of security over its assets

Preferential Creditors

There are no preferential claims in this liquidation

Crown Creditors

The Declaration of Solvency included £100,003 owed to HMRC in respect of Corporation Tax My firm's Oundle office have dealt with the final accounts, tax computations and corporation tax returns in this regard. All pre appointment returns have been filed and no further liability is due. I have now received written confirmation from HMRC in this regard.

Final returns have been submitted in respect of VAT There is no liability in this regard

Unsecured Creditors

The Declaration of Solvency included one other unsecured creditor with an estimated total hability of £7,000, Mrs June Wilkinson, in respect of her director's loan account. This claim has been agreed at £6,952 plus statutory interest of £646 and has been paid in full

No other claims remain outstanding or are anticipated

DIVIDENDS

As referred to above a distribution in specie was made to Mr J Wilkinson, subject to the over distribution refund. First and final capital distributions have now been made as follows

As previously advised there is no likelihood of a further distribution to shareholders as the funds in hand have been used or otherwise allocated in defraying the costs of the liquidation

LIQUIDATOR'S ACTIONS SINCE APPOINTMENT

Action taken in respect of the company's assets is set out above, together with details of the funds received

The company's accounts and tax affairs have historically been dealt with by this firm's Oundle office who have dealt with outstanding tax matters as referred to above

PRE-APPOINTMENT REMUNERATION

The members previously authorised the payment of a fee of £3,000 for this firm's assistance in preparation of the Declaration of Solvency and in producing and circulating the notices for the meeting of members prior to my appointment at a meeting held on 16th March 2012. This fee has been paid in full from liquidation funds and is reflected in the enclosed receipts and payments account

LIQUIDATOR'S REMUNERATION

The Liquidator's remuneration was previously authorised by members at the initial meeting held on 16th March 2012 to be drawn on a time cost basis at intervals as appropriate. My time costs to date amount to 79 hours at an average composite rate of £174 per hour resulting in total time costs of £13,712. I have drawn £11,500 against these time costs to date the balance of which has been written off as irrecoverable. Schedules of my time costs to the anniversary are attached at Appendix 1.

- Liaising with accountants and tax advisors as regards the liabilities to HMRC

4 Realisation of Assets

- Liaising with the Directors and their representatives in respect of distributions
- Liaising with agricultural agents as regards valuations of crops and stocks

LIQUIDATOR'S EXPENSES

My expenses to date amount to £38,487 This figure comprises £485 paid by my firm and recovered from the liquidation and £38,002 paid direct from liquidation funds

The disbursements of £485 were in respect of my bond premium, statutory advertising, postage, photocopying, stationery and Companies House search fees. The expenses of £38,002 were in respect of legal costs, accounting fees and agricultural agent's fees. The cost of the Gazette Notice of the final meeting is £77 plus VAT and is included in these figures. A detailed schedule is attached to this report.
