Accounting Policies

YEAR TO 31 AUGUST 2004

BASIS OF ACCOUNTING

The accounts are prepared under the historical cost convention, and comply with applicable UK Accounting Standards.

The company is exempt by virtue of Section 228 of the Companies Act 1985 from the requirement to prepare group accounts. These financial statements present information about the company as an individual undertaking and not about its group.

The company is exempt from the requirement of Financial Reporting Standard 1 to prepare a cash flow statement as it is a wholly owned subsidiary undertaking of Allied Domecq PLC, and its cash flows are included within the consolidated cash flow statement of the group.

The company is exempt under paragraph 3(c) of Financial Reporting Standard 8. Related Party Transactions. from disclosing transactions with entities that are part of the group.

The financial statements have been prepared on a going concern basis because Allied Domecq PLC. a parent undertaking, has confirmed its intention to support the company for the foreseeable future.

FIXED ASSET INVESTMENTS

Fixed asset investments are stated at cost. less provision for any permanent diminution in value.

FOREIGN CURRENCY TRANSACTIONS

Transactions in foreign currencies are recorded using the rate of exchange ruling at the date of the transaction. Monetary assets and liabilities denominated in foreign currencies are translated at year end rates, any gains or losses on translation are taken to the profit and loss account.
